- 3. You may not leave the state while this matter is pending without the permission of the court.
- 4. You must notify your attorney, bondsman, and the clerk of the court of any change of address.
- 5. You understand that when recognizance has been set in the District Court on a felony charge, the recognizance will remain in effect until arraignment in the Superior Court when a new recognizance will be set.
- 6. The following are special conditions you must abide by:

G.L. 1956 § 12-29-4 and will subject a violator to arrest.

Note: You understand that if you violate any condition of your release, a warrant for your arrest may be issued immediately. After arrest and hearing, if you are determined to have violated your recognizance, the terms and conditions of any further release will be redetermined. At that time you could be held without bail, have your bail increased, or you could be found in contempt of court. You also understand that the State may proceed against your sureties for violation of this recognizance.
