It shall be the responsibility of the Contractor to notify all subcontractor and suppliers he proposes to use for the various parts of the work of any changes or modifications contained in this Addendum. No claim for additional compensation due to lack of knowledge of the contents of this Addendum will be considered.

Pre-Bid Meeting:

A Mandatory Pre Bid Conference was held on June 10, 2016 at 7:30 AM at the first floor lobby. The following items were discussed:

1. Bids are due on June 17, 2016 and are to be delivered to Purchasing, Room 1006, at the RI Traffic Tribunal located at the Pastore Center, 670 New London Ave. Cranston, RI. Bids must be delivered before 10:00 AM to be considered.
2. Any contractor who was present at the pre-bid meeting may return to Courtroom 5 before the bids are due. Visits to the courtroom are to be scheduled with Steve Kerr, whose office phone number is 401-222-4999.
3. All present at the pre-bid meeting toured Courtroom 5.
4. All present at the pre-bid meeting toured Courtroom 4, which was recently renovated, as an example of the quality of work that is expected.

 - a. Delete General Restoration Note 1 and insert the following:
 - "1. WOOD SURFACE RESTORATION OPERATIONS VARY UPON LOCATION. 'RE-FINISH WOOD' IN THE CONSTRUCTION DOCUMENTS INCLUDES CHEMICALLY STRIPPING ALL WOOD THROUGHOUT. IN ADDITION TO CHEMICALLY STRIPPING THE WOOD, 'RE-FINISH WOOD' MAY ALSO REFER TO THESE ADDITIONAL RESTORATION OPERATIONS:
 - A. ABBRASIVE SANDING & RE-FINISHING

B. CLEANING OF 'HAZE' WITH TRISODIUM PHOSPHATE SOLUTION AND A CLEAR WATER RINSE

CONTRACTOR TO DETERMINE MOST APPROPRIATE RESTORATION OPERATION IN THE FIELD."

2. Drawing A1.01:

- a. Delete specific construction note 1A from Jury Room 440.

Clarifications:

1. The electrical drawings show one new duplex floor receptacle under the clerk's desk in Courtroom 5, but no new receptacles under the attorney tables in front of the clerk's desk. Should new receptacles be provided under these tables?

Response: No, there are already floor recessed receptacles under the attorney tables.
